and House have pending legislation to authorize the FAA to modify regulations to allow many pilots to fly without having to take the nowrequired flight physical. In addition to medical reform, the bill also includes important provisions regarding the NOTAM system and enforcement actions. Check it out...and asking your Senators and Congress member to become sponsors and support the bill will help to ensure its passage. Please do so.

And finally, kudos to our stalwart gang that volunteered time to repair the airport tetrahedron. Once we get a fresh coat of paint on, the project will be complete. Well done to all involved.

Meeting Minutes:

April 19, 2015

Officers: Vice President Mark Scott called the meeting to order at 10:10. Bob Spaulding arrived at 10:20. Officers present: Bob Spaulding, Mark Scott, Bill Jagoda, Rick Beebe. There were 23 attendees including 2 visitors.

Build-a-plane: Mark Scott presented the progress of the build-a-plane project. He's gotten preliminary permission from the city to use half of the snowplow hanger. He made a presentation at Wilcox High School. A small group of kids showed up and were very excited. We would need to form an entity to own the airplane. We can either make the Chapter a

501(c) 3 form a separate foundation or work under another group. EAA has insurance for these types of projects. Mark and Bob Spaulding will work through the process with the IRS.

He has a \$10,000 loan commitment from chapter 143 in Oxford.

EAA will be building five sets of wings at AirVenture purposely as jump starts for build-a-plane projects. Mark as put our name in to receive a set. Right now he thinks an RV-12 would be the best plane to start with but it's not clear what wings EAA will be building. Other choices are Rans S-19, Zenith 601 or Sonex.

Preliminary plan is to build for 3 hours on Monday nights and 3 hours on Saturdays. Mark wants to put up a banner advertising it and encouraging visitors.

Questions we have to answer to be selected for a set of wings:

Why does your Chapter deserve a set of wings? To cite our Young Eagles record. Giving kids something to do after/other than flying. We've flown 2200 kids one at a time.

How does your Chapter intend to raise funds? Charitable donations, businesses, go-fund-me web sites. We need roughly \$67,000 to buy a kit. What's the plan for the finished plane? Sell it and use the money for the next project.

Other information? Chapter 27 has been around a long time. Experienced building chapter. Enthusiastic group. Mark will put together a detailed project plan. We have an Oshkosh award winner. Joe Gauthier available. Success with boy scouts.

If people have other thoughts or suggestions for the project you can email Mark at vicepresident@eaa27.org MMK Fly-in: The fly-in did well last year and will be repeated this year. Bob would like a larger Chapter presence this year. Warbirds over the beach: Mike Zemsta showed a poster for a warbird fly-in in Virginia Beach, Virginia in May.
